
⊘ January Presentation **⊘** The Kalashnikov-Stoner Visit – May 1990

VGCA charter members Ed Costello (*at right*), Addison Hurst (*below*) and Bill York shared the story of how Mikhail Kalashnikov came to the United States and met with Eugene Stoner – and the role that the VGCA played in getting the designers of opposing quintessential Cold War small arms together. This role is also probably the most controversial action ever taken by the VGCA.

It all started when Dr. Ed Ezell, the Smithsonian Institution's military historian/weapons expert, noted author, and VGCA member, traveled to the Soviet Union in 1988. While there, he met Mikhail Kalashnikov, the man who designed the AK47 rifle. At



the time, the Smithsonian had a program to document in film great innovators in technology.




Dr. Ezell started to formulate a plan to bring Kalashnikov to the United States to take part in this program. Following a presentation by Dr. Ezell to the VGCA in the fall of 1989, the VGCA officers authorized \$2000 to sponsor Kalashnikov's visit.

Kalashnikov, his daughter, and an interpreter, arrived in May 1990. Ed Costello shared several stories of taking Kalashnikovs shopping and out to eat prior to his meeting Stoner. It was interesting to contrast Kalashnikov - a hero and celebrity in the Soviet Union for his work as a weapons designer, but relatively penniless - to Stoner – a virtual unknown in his own country but who received a commission on each M16 produced and was a wealthy man. The two men got together at NORVA Rod and Gun Club at Star

Tannery, Virginia and were interviewed by Dr. Ezell over the course of several days. Ultimately, there were 13 interview sessions and over 18 hours of video recorded (unfortunately, computer issues prevented the replaying of portions of those videos during the January presentation).

Addison Hurst, Bill York, and others shared stories and anecdotes of the Kalashnikov visit as well as several subsequent visits by VGCA members to Russia as guests of the Kalashnikov family. Though Mikhail Kalashnikov passed away in 2013, several members remain in contact with his daughter.

I mentioned that the VGCA hosting Kalashnikov was a controversial act. Some members viewed the designer of the weapon that killed many U.S. soldiers in Viet Nam and many allied soldiers around the world as unworthy of our time and treasure. Action was actually taken to initiate a lawsuit against the VGCA officers, though it was subsequently dropped.

It was great presentation followed by an associated Show-n-Tell that featured many variants of the both Kalashnikov and Stoner designs. Our sincere thanks go to Ed, Addison, Bill, and the others who made it possible!

♦ January Meeting **♦**

♦ January Business: VGCA President Bernie Breighner called the meeting to order at 7:00 p.m. After reciting the U.S. Pledge of Allegiance and observing a moment of silence for those defenders of our nation who have paid the ultimate sacrifice, Bernie welcomed the large crowd to the January meeting. There were 102 members and guests in attendance − the largest VGCA meeting in recent memory (*see picture below*)! Guests were introduced by their sponsors/hosts or introduced themselves.



The big announcement of the evening was to congratulate Mr. Jim Burgess on his selection as the VGCA Member of the Year for 2019! Jim, a recognized expert on Civil War firearms and past President of the VGCA, was selected by the membership for his notable contributions to our association over the past year. Additional details are in the article below. Jim received a plaque and a \$100 Gift Certificate.

Bernie reminded our annual members that dues were due on January 1st.

Treasurer Shannon Zeigler provided a quick update on VGCA finances and reminded everyone that our operating budget is provided by the money we make at our gun shows. The next VGCA Gun Show is March 28th and 29th at the Prince William County Fairgrounds. Shannon handed out show flyers for members to distribute.

Show Director Rick Nahas announced that there are only 20 open tables for our March 2020 Gun Show and that the Executive Committee was considering a second spring gun show in May (since this membership meeting, the Executive Committee has met and approved the second spring show – dates are 16-17 May 2020).

Bernie provided an update on gun control efforts by the Virginia General Assembly. Four bills have recently passed the Senate. They are:

- "Red Flag" Law (loss of firearms due to determination that a person is a threat to himself or others)
- Limit on Handgun purchases to one per month
- Universal Background Checks on all firearms sales
- Jurisdictions allowed to restrict firearms at local events

These bills are expected to pass the House of Delegates and be signed into law by the Governor. Other bills have been introduced but not acted upon – yet. Bernie noted that several VGCA members participated in Lobby Day down at Richmond on January 19th and that the pro-gun rally was <u>very</u> well attended. The Officers and Directors will discuss contributing to the Virginia Citizens Defense League (VCDL) and/or National Rifle Association Institute for Legislative Action (NRA-ILA). This session of the Virginia General Assembly represents the greatest threat to gun owners in Virginia in at least a generation. Members were asked to contact their Delegate and Senator early and often and let them know where you stand!

TJ Parmele asked that members "like" us on Facebook. This represents a tool that we can use to get information out quickly to our membership (such as new legislation for example).

Dave Litchfield passed around a sign-up sheet for a trip to the American Armour Museum in Danville, VA. Details below.

Steve Gomes introduced Mr. Frank Cambria as his incoming replacement as Show Security Manager.

The NRA is keeping up on them but needs volunteers to attend these meetings in Richmond, sit through the hearings, and offer input whenever possible. CMP UPDATE

NEW CMP IMPROVEMENTS AND PROGRAMS

The Civilian Marksmanship Program (CMP) is much more than a source for surplus U.S. firearms, parts, ammunition and accessories. It is constantly seeking ways to evolve and improve or introduce new programs in order to support firearms safety, marksmanship, training and competition for US Citizens with an emphasis on youth. Some of the improvements or new programs that were introduced during the past year or will be introduced this year include:

- The CMP's North Store at Camp Perry, Port Clinton, Ohio will be moved from its location on Camp Perry Building 2500 to Building 3, next to the CMP Headquarters, the CMP Armory, the National Match Welcome Center and the Post Exchange (PX). Store hours are Thursday through Saturday, 8:30am-4:00pm.
- The CMP website at www.thecmp.org has been updated with a new design and layout, and improved navigation and search functions.
- The CMP Smallbore Department will offer match sanctioning for smallbore to include Outdoor 3-Position and Prone matches, and indoor 3-Position 50-foot matches.
- New Pistol events have been added to the 2020 National Match schedule. These include a 2-Man Team Event and a 4-Man Team event. A new "Triple Crown Award" has been added.
- An Unknown Distance Range has been added at the CMP Marksmanship Park in Talladega, Alabama. It has over 100 steel targets out to 625 yards.
- A new Rimfire Sporter Small Arms Firing School (SAFS) has been added to the 2020 National Match schedule and will take the place of the old Rimfire Sporter Clinic. It will be given every year the day before the Rimfire Match by members of the U.S. Army Marksmanship Unit and participants will be able to learn more about Rimfire Sporter in the classroom and the firing ling before competing in the match. The SAFS is scheduled for July 18.
- The CMP has updated its rulebooks for Pistol, Rifle, Games, Smallbore and Long Range matches.
- The Small Arms Firing School remote clinics that are held around the country will have a number of new locations. The SAFS remote clinic name was changed to "Rifle/Pistol Marksmanship 101."
- The Garand Collectors Association donated \$10,000 to the CMP to be used for additional scholarships for student-athletes.
- The CMP auctions rifles, rifle parts and accessories on its auction site, http://thecmp.org/cmp_sales/guns-on-auction/. The auction program is an extension of the CMP ESTORE. Everyone who is registered in ESTORE is automatically registered for the auction program.

Remember, the VGCA is a CMP affiliated club. The VGCA's Affiliation number is 026160.

♥ VGCA March Gun Show Update **♥**

The Executive Committee approved a change to the set up procedures for the VGCA March Gun Show. Set Up will now begin at 1:00 p.m. (vice the previous set up time of 2:00 p.m.). Also, VGCA members who help as a set up volunteer will be allowed to start setting up their tables AFTER set up is complete and AFTER they check-in and receive their show package and vendor badge.

♠ Attention: Accurate Powder Recall ♦

Accurate Powder Recall Notice: General Dynamics Ordnance and Tactical Systems Canada Valleyfield, Inc. (GD-OTS), has determined a potential defect relating to <u>certain lots of Accurate 2495, 4064 and 4350 propellants manufactured for Western Powders, Inc. prior to October 1, 2016 and packaged under the Accurate brand name in 1 lb. and 8 lb. canisters, may be defective.</u>

The use or storage of this product may result in combustion, fire damage and/or possible serious injury or property damage. Some signs of degradation include, but are not limited to, container lid deformation, discoloration of the containers in the lid area, presence of red fumes when the container lid is opened, or the presence of a strong acidic odor.

GD-OTS and Western Powders, Inc. are recalling the following powders packaged under the Accurate brand in 1 lb. and 8 lb. containers:

What you should do:

- 1) Immediately fill the container with water, which will render the product inert and safe for disposal.
- 2) Notify Western Powders, Inc. and 406-234-0422, or customerservice@westernpowders.com mailto:customerservice@westernpowders.com. We will provide you with instructions to photograph the bottle showing the lot number and provide refund information.
- 3) DO NOT load ammunition with affected powder

NOTE: This recall does not extend to loaded ammunition. Performance of ammunition with propellant showing no signs of degradation will not be altered, provided recommended storage conditions are followed. It is recommended that loaded ammunition be checked regularly for deterioration. Safety is our first concern. ♦ Show-n-Tell ♦

NOTE: Anyone bringing in items for Show-n-Tell, please hold them up so the members can see it. This will also help your Volunteer Photographer get a decent photograph of the special item you brought to show, and people who could not attend the meeting can see it clearly in the newsletter. Thank you!

With over 100 people at the meeting and the presentation on the designers of two very iconic firearms, we also had a <u>very</u> large selection of associated Show-n-Tell items. We even ran out of table space! Just a portion of the items are shown at right.



Member 1 brought in several rare pieces in honor of Eugene Stoner. The first was an original Dutch AR10 made in 1959. Chambered in 7.62x51 NATO, the AR-10 was the initial Stoner direct gas impingment design before the design was "scaled down" to accommodate the 5.56x45 cartridge (aka – the M16/AR15). One interesting feature of the AR10 is that the safety lever positions are different from the M16/AR15 that most of us are used to. Included with that AR10 was a original "waffle" magazine – called that because of the pattern of reinforcing ridges pressed into the body of the magazine, giving rigidity while allowing thinner/lighter gauge steel to be used.



The next item shared by Member 1 was another original – this one a Colt 601 (at left). This is the first M16 adopted by the U.S. military (in this case, the United States Air Force) and is easily identified by its green furniture and triangular shaped charging handle. Though made by Colt, it has Armalite markings as well. Stoner worked for Armalite, a division of the Fairchild Aircraft Factory Company. Armalite sold the design rights to Colt in 1959. This example has a rare 3x Delft scope (made in the Netherlands for Colt) mounted on the carry handle. The magazines initially issued with the Colt 601 were also 20-round "waffles."

Member 1 also shared a Knight's Armament SR25 (at right). The SR25 was Stoner's last design and like the AR10, was chambered in 7.62x51. In 2005, a modified version of the SR25 won the U.S. Army Semi-Automatic Sniper Rifle competition and



is currently issued to Army snipers as the M110 Semi-Automatic Sniper System.



Member 2 (at left) brought in some memorabilia commemorating the Kalashnikov-Stoner Meeting. The first was a tee-shirt designed by Mrs. Member 2. The other item was one of two plaques (also designed by Mrs. Member 2) signed by Kalashnikov, Stoner, and others who were at the May 1990 meeting. One went to General Kalashnikov and this one was intended for Mr. Stoner. Unfortunately, Stoner had to leave NORVA before the plaque was fully signed and he passed away before it could be presented.

Member 3 brought in AK buttstock that was autographed by Kalashnikov during a visit to the U.S. circa 2000 (unfortunately, no photo is available of this rare and valuable artifact).


Member 4 shared two precision rifles made by Knights Armament Company (KAC). The first was an Enhanced Match Rifle (*below left*). The Enhanced Match Rifle is a civilian version of the SR25/Mk11 U.S. military sniper rifle. It is chambered in 7.62x51 and features the same 20-inch barrel as the military model. The upper and lower receivers are closely fitted and serial numbered to each other. The trigger is a crisp two-stage target trigger.





The second KAC rifle displayed was their SR15 Match Rifle (*above right*). This rifle features military markings of "M-4 Snipr R.A.S. – PN: 99167" and is one of only 18 sold to the public. "R.A.S." stands for Rail Adapter System and "PN" for Part Number. It has a hand-lapped Kreiger 20-inch stainless steel barrel with a 1-7.7 twist, a flat-top upper receiver, a KAC two-stage trigger, chromed bolt and bolt carrier group. When sold, these rifles were guaranteed to shoot better than 1 MOA.

Member 5 brought in a semi-automatic version of the Hungarian AK63 (at right) with an underfolder butt stock. In Hungarian service, the AK63 replaced the AMD65 in 1977. The AMD65 featured a forward vertical hadgrip that was easily damaged in service and was more expensive to manufacture than the AK63. Both the AK63 and earlier AMD65 are chambered in 7.62x39. Member 5 purchased this James River Armory made example (which utilized a Hungarian parts kit and the necessary 922(r) U.S. made complaince parts, including a semi-automatic receiver) at Camp Perry, Ohio during the National Matches in 2014.



Member 6 shared a "pre-ban" Chinese semi-automatic AK47 (*at right*). Frequently called a "Spiker" because of its folding spike bayonet, this is a semi-automatic version of the Chinese AK that was often encountered by U.S. troops in Vietnam. Imported in the 1980s (exported by Polytech), it is chambered in 7.62x39.


Member 6 also shared a Colt 653 (*image taken from internet shown below*). This select-fire M16 variant, chambered in the standard 5.56x45 NATO, was never adopted by the U.S. military but was available as a Commercial-Off-The-Shelf (COTS) item and marked "M-16A1". It features a 2-position collaspsible stock and other early production features (tear-shaped forward assist, no case deflector, etc.). This example, with its "fun switch" allowing full automatic fire, is a transferable NFA firearm.







Member 7 (at left) brought a Spanish "Destroyer Carbine." So named because of its rollmarked warship on the top of the receiver, this handy bolt action carbine fed via a 5round single stack detachable magazine and was designed for use by the Spanish National Police. The Destroyer carbine was initially manufactured by Gaztanaga y Compania (later by Ayra Duria S.A.) and chambered in 9mm Bergman-Bayard (aka 9mm Largo or 9x23). It was used from 1935 until 1969.




Keeping with the Kalashnikov/Stoner theme, Member 8 (*at left*) brought in a semi-automatic AK74 amdein the U.S. from a parts kit. Chambered in the light 5.45x39 Russian caliber, this represented a design development by the Soviets to adopt a smaller, lighter round (which means a soldier can carry more rounds for the same amount weight) similar to the 5.56x45 used in the M16.

Member 8 also brought in several books, to include "The Gun" by Pulitzer prizewinning *New York Times* reporter C.J. Chivers. It is an excellent book that tells

the story of the AK47. Other show-n-tell items were the book "Kalashnikov" by Mikhail's daughter Elena Kalashnikova and an AKM manual.

Member 9 shared another Chinese semiautomatic AK variant – this one a Norinco Type 56S-1. Also chambered in 7.62x39, it features an underfolding stock. Though different company names were stamped on these rifles at different times (including Polytech), it is believed that all were made at factory /66\. This example was an early pre-ban import.



Member 10 brought both a Stoner and a Kalashnikov. The first was a Colt M16A1 (*below left*). This diminuative carbine was used by U.S. special forces in Vietnam. With its short 10-inch barrel and aluminum collapsible stock, it was distinctive enough in appearance and sound to draw the attention of enemy snipers, earning the nick-name "Dead Man's Gun."





Member 10 also brought a Chinese AK47 (*above right*). This is example is the "real McCoy" - a transferable select fire Type 56 brought back from Vietnam. Like many captured weapons brought back from that war, it was originally in poor condition. This milled receiver example was restored.

Member 11 proudly displayed his modern reproduction of the AR180 (*at right*). With a Nodak Spud lower receiver and a complete upper by Brownells, this semi-automatic short stroke gas piston is a fairly faithful rendition of another Eugene Stoner design, though this one uses a standard AR15 lower. The original AR18 (select fire) was developed as an alternative to the AR15/M16. Never actually adopted by any military, the AR18 (the AR180 was a semi-automatic version for civilian use), it nonetheless influenced other designs, including the British SA80, the Belgian FN F2000, the Japanese Howa Type 89, and the German Heckler & Koch G36.





Member 12 brought two 7.62x39 AK variants to share. The first was a Century International Arms Wasir 10 (*left*), a version of the Romanian AKM (technically, the AK47 has a machined receiver while the stamped receiver version is referred to as the AKM47). In order to meet U.S. import restrictions, the Wasir 10 is built in Romania to accept only a 5- or

10-round singlestack magazine. It is then modified in the U.S. to accept a regular double-

stack AK magazine, with the appropriate number of U.S. made parts added to insure compliance with U.S. law.

The second rifle was not a rifle at all, but rather a AK-style pistol called a "Draco" (at right) This example features a 12.25-inch barrel.





Member 13 shared what he called "the original assault weapon" – a reproduction medieval Flail (*above*)! A flail is a weapon consisting of a striking head attached to a handle by a flexible rope, strap or chain. The primary advantage of a flail was the ability to get around an opponent's shield. Requiring space to swing, it chief disadvantage was that it was difficult to use in close in close quarters. Fortunately, this weapon was zip-tied for our safety!



had the rare Bosnian two ridge mag as well as the even more rare one ridge and Fluer de Lis magazines with the their unique leaf springs (*seen at right* – *far right*).

Member 14 explained that he couldn't afford to collect a lot of AKs or ARs, so he shared some of his collection of much less expensive AK magazines (*left and below*). He had everything from the original heavy gauge Soviet "slab side" magazine (too heavy) and the light aluminum "waffle" mag (too fragile) to the Eastern European standard steel (just right) and bakelite magazines (both standard and "high top"). He had "flat back" Chinese mags – including an "all stamped" version that did not have reinforced welded feedlips, a Romanian cut-away trainer, and 40-round mags for the RPK squad automatic weapon. He



Member 14 brought another excellent book on the Automat Kalashnikov, this one called "AK-47 – the Grim Reaper" by Frank Iannamico.



Member 15 shared a special medallion minted at St Petersburg Mint in honor of Kalashnikov's 90th Birthday (*at left, upper left*) and several tomes on the legendary rifle and its designer. The one pictured at left was printed in Russian!

A TRIP TO THE MUSEUM: THE WALLENBERG COLLECTION AT LÄCKÖ SLOTT


During Sweden's "Age of Greatness" (approximately 1560-1720) hunting was a form of entertainment for the nobility. For princes and noblemen, hunting game in the forests was considered useful practice for warfare. Special rooms were furnished in castles and large country houses, where weapons and armor were displayed for visitors. For the upper classes, hunting weapons were important status symbols that combined advanced technology in firing mechanisms with expensive materials and artistic design. This carried over to their firearms and other weapons used in war and many of the private weapons used by the nobility in the hunt were the same that they used on the battlefield.

The current Läckö Slott, or Läckö Castle, situated on the shore of Lake Vanern, was built by Swedish Field Marshal Count Jacob Pontusson De la Gardie on the site of an earlier castle after the Swedish crown granted him the site and surrounding lands in 1615. He embarked on an ambitious building program which was continued by his son, Count Magnus Gabriel De la Gardie when he took over the castle in 1654 and the large, magnificent castle we see today is largely a result of their efforts.

Läckö Slott, like many Swedish castles, has its armory which contains a substantial array of firearms. On display are wheel-lock guns richly inlaid with precious metals and mother of pearl, matchlock muskets with carved stocks, and pistols with stocks of polished ebony and ivory.

Count Magnus De la Gardie fell out of favor with the King Charles XI and the castle was confiscated and much of the original furnishings and property (including the armory, was sold. The current gun collection on display was created by the diplomat and industrialist Axel Wallenberg (1874-1963). After his many years abroad he started to build a magnificent collection of the finest examples of wheel-lock guns from the 16th and 17th centuries. Wallenberg enhanced his collection when he acquired several exquisite weapons when the collection belonging to the Dukes of Saxe-Weimar was sold in 1927. On two separate occasions Axel Wallenberg donated large parts of his collection of firearms to the Swedish Army Museum. These weapons are displayed to the public for the first time Läckö Castle's armory.

Although not large, the collection contains some of the finest examples of the gunmaker's art and decorated arms in the world. The display cabinets in the armory are well lit and the guns are numbered with corresponding descriptions in booklets attached to each display case.

Läckö Castle with its medieval foundations and well-preserved splendor is famous for its superb location on an island in Lake Vanern and its magnificent baroque interior decorations, especially the painted ceilings in its 240 rooms. There is a small gift shop in the castle, a café and a restaurant nearby, and is surrounded by a nature preserve. There is lodging, camping nearby and a guest harbor below the castle walls. Operas and classical music concerts are performed in the castle courtyard during the summer and the fishing harbor of Spiken, with its many eateries, is close by.

The castle is open May 1st – September 30th. At other dates entrance is by request. It is usually open from 10am to 6pm. Guided tours take about 45 minutes to an hour and are about 80-120 Swedish kronor per adult (depending on dates). Under 26 years old is free. Some of the tours are in English. Parking costs 30 kronor.

Läckö Slott is 23 kilometers north of Lidköping in Vastergotland. During the summer bus 132 runs three times a day from Lidköping to the castle. Additional information is available on the website: http://www.lackoslott.se/Default.aspx. The phone number is +46 510 48 46 60.

②Breaking News – HB961 not approved by Virginia Senate! **②**

On February 17th, the Virginia "Assault Firearms" ban that would have eliminated sales of so-called "Assault Firearms" as well as possession of suppressors or any magazine, belt, drum, strip that can hold more than 12 rounds was stopped in the Senate Judiciary Committee. The committee vote killed this bill for this legislative session, but gun owners are not out of the woods as gun control proponents continue to push this and other measures. Still pending legislative approval and likely to be signed into law by Governor Northam in the next few weeks are universal background checks (eliminating private firearm sales), a "Red Flag" law (allowing firearms to be removed from individuals determined to be a threat to themselves or others), and a limit on handgun purchases to one per month.
