© February Presentation:

The High Power by Fabrique Nationale

Member Carlos Davila gave a presentation on the High Power pistol by Fabrique Nationale (better known by its abbreviation "FN"). Carlos opened with a brief history of John Browning and his relationship/association with FN.

John Moses Browning, by almost any measure the most brilliant firearms designer/inventor in history, began his association with FN in 1897 when he negotiated several firearms licenses with the Belgian firm to allow them to



manufacture some of his designs. When Winchester – a company which had enjoyed a long and successful partnership with Browning – balked at paying Browning a royalty fee per gun instead of the usual single fee for the patent when presented with a new semi-automatic shotgun design, Browning took the design of what would ultimately become the Browning Auto-5 to FN. FN agreed to Browning terms and would manufacture the Auto-5 for nearly a century!

John Browning died on November 26, 1926, in Liege, Belgium, literally while working on his next pistol design – the future High Power (also known as the Hi-Power, BHP (for Browning Hi-Power) and the HP35 (based on 1936, the year the design was finalized)). Design work on the new pistol was taken over by FN small arms designer Dieudonné Joseph Saive, then working as Mr. Browning's assistant. The pistol they were working since 1922 on was intended to meet the French Army's requirements for a new service sidearm. One of those requirements was for a large capacity (15-rounds) magazine, which necessitated an unusual-for-the-time double-stack magazine design. While double-stacks had been used in sub-machineguns, their use in handguns at the time was quite rare. The final design could carry 13+1 (13 in the magazine plus one in the chamber) 9mm Parabellum rounds. This capacity would result in the design being called the "Grand Rendement" (translated as "High Yield"), "Grande Puissance" in French, and "High Power" in English.

The High Power was a short recoil, tilting barrel, design that would be chambered in 7.65x21 Parabellum, 9x19 Parabellum, and much later, the .40 S&W. Though the design did not win the contract for the new French sidearm, it did enter production in 1935 for the Belgian military. Ultimately, over 1.5 million examples would be produced over the next 82 years, most by FN but also licensed and unlicensed copies were made in Argentina, Hungary, India, Bulgaria, and Israel. The High Power has the distinction of

being the only handgun simultaneously produced by both sides during the WWII – by the Germans at the captured Belgian FN factory and by the Canadian firm Inglis (using blueprints that escaped right before the German occupation) for the allies. The High Power is still the official sidearm of both Canadian and Australian forces.



Mr. Davila (*at right*) has serious credentials regarding FN firearms. He was the FN area sales manager for North and South America, Spain, and Portugal during the 1980s. At the time, FN owned Browning, Beretta, and 30 other companies. Between 1977 and 1981, there were contracts with Bolivia, Argentina, Venezuela, Ecuador, Brazil, Chile, Portugal, and Mexico.




© February Meeting Notes


One of the items that sets our show apart from any others in the region is our free Evaluation Table. Show attendees are allowed to bring as many firearms as they wish to be examined and evaluated at no charge. Many times, learning about "that ol' gun they found in grandpa's closet" is the only reason that some people even attend our show. Ably examined by VGCA members Jim Burgess and Gary Holderman, about two dozen firearms crossed the Evaluation Table over the weekend, including a Model 1895 Winchester-Lee Navy Rifle, a Model 1861 Remington percussion revolver, a French flintlock pistol, a Colt Model 1911, and a nice German Drilling!

The other thing that sets our shows apart are the superb firearms educational displays put together by our members. While there were only three judged displays at the spring show, they made up in quality what they lacked in quantity. In addition to the monetary awards for 1st, 2nd, and 3rd place, the VGCA Officer and Directors voted to authorize ribbons for two new awards at this show – the best antique firearm displayed and the best military firearm displayed. Once again, a big "thank you!" goes out to Jim Burgess for organizing the display judging and tabulating the judges' scores. The results were:

1st Place "U.S. Navy Jenks Mule Ear Carbines and Rifles" by Marc Gorelick

2nd Place "Marked Handguns" by George Dungan

Among them were a Danish M/49 (Sig P210) made for the Haerens Tekniske Korps (Army Technical Corps), an H&K P2000 with Falls Church Police markings, and a S&W Victory Model made for the U.S. Navy during WWII.


George (at left, on the left) also received an award for **Best**Military Firearm for his Smith & Wesson 2nd Model .44

New Virginia Gun Laws Go Into Effect on July 1st

Several pro-2A Laws were signed into effect by the Virginia Governor during the latest session. The laws will come into effect as of Jul 1, 2023. Probably the most interesting for club members is HB 2387. **HB** 2387, would allow gun owners to write off up to \$300 a year on their state taxes when they buy "firearm safety devices," including gun safes, lock boxes and cases.

"Taxpayer shall be allowed only one credit under this section per taxable year. The taxpayer shall submit purchase receipts with the income tax return to verify the amount of purchase price paid for the firearm safety device or firearm safety devices," the bill states:

A gun safe with a selling price of \$1,500 or less. For purposes of this subdivision, "gun safe" means a safe or vault that is (i) commercially available, (ii) secured with a digital or dial combination locking mechanism or biometric locking mechanism, and (iii) designed for the storage of a firearm or of ammunition for use in a firearm. "Gun safe" does not include a glassfaced cabinet. Any discount, coupon, or other credit offered by the retailer or a vendor of the retailer to reduce the final price to the customer shall be taken into account in determining the selling price for purposes of this exemption.

The nonrefundable credit can be claimed on state tax returns starting in the 2024 tax season and extending to 2028. It can only be applied to eligible equipment purchases from federally licensed firearm dealers. The credit cannot be applied to the costs of purchasing a firearm itself. The total amount of tax credits allowable under the new law is capped at \$5 million per year. According to the legislation, the credit will be granted on a "first-come, first-served basis."

The following laws were also signed by the Governor during this session. Warning: These laws will not go into effect until July 1, 2023

- Switchblades will be legal to be concealed, such as in your pocket or in a toolbox, etc. Do NOT carry a <u>concealed</u> knife (switchblade or not) that has a stiletto-type blade with one or two sharp edges that continuously narrows down to a sharp tip for stabbing and is not designed for cutting.
- CHP holder information in the Virginia State Police records will now be protected from dissemination except to law enforcement for a criminal investigation or prosecution of an individual who is a CHP holder. No "fishing expeditions" by any law enforcement agency.
- United States Concealed Carry Association classes will be accepted as proper training for those applying for a CHP.
- For those with a religious exemption from having a photograph on their state-issued ID, they can purchase a gun at a gun show and the Virginia State Police will run the background check with the non-photo ID.



CMP UPDATE

CMP Surplus Ammunition purchase is open to all qualified individuals!

The Civilian Marksmanship Program has acquired a supply of surplus ammunition. Beginning April 11, 2023, qualified individuals will be able to purchase surplus .30/06 in 400 round cans; .30 Carbine in 240 round boxes; and .22 in a 500-round brick. Those wishing to purchase can use the CMP Universal Order Form on the CMP website at https://thecmp.org/cmp_sales/ordering-information/ to place their order. Customers must have a current CMP affiliated club membership (the VGCA is a CMP affiliated club) and proof of citizenship.

CMP has set a limit of 1 can for the .30/06 ammunition, 2 boxes of .30 Carbine, and 2 bricks of .22 per person. Orders will be processed in a first-come, first-served sequence. Ammunition will be available via E-Store and mail order. The Ohio store will have an allocated amount of each caliber available for customers to purchase. The ammunition will ship from Anniston and not physically available in the Ohio store. Anniston and Talladega will also have allocated amounts available for store customers to purchase and will be physically available in the store.

Additionally, certain quantities of the ammunition will be reserved for competitors to buy at CMP events and for multiple years. For example, later this year ammunition will be for sale for registered and qualifying competitors at the Eastern Games, CMP Bianchi Cup, the Talladega 600, the National Matches and the New England Games. Competitors will fill out order forms at these events and the ammunition will be shipped from Anniston AL.

VGCA GUNS OF DISTINCTION:

CHARLES DE GAULLE'S LEBEAU-COURALLY SIDE BY SIDE SHOTGUN

In 1939, Charles, Count of Flanders and Prince of Belgium, (*photo left*) the brother of Belgium's King Leopold III, commissioned the Liège arms manufacturer Auguste Lebeau-Courally, to manufacture two custom shotguns intended as gifts. Only a few months later, Belgium was under attack by German troops who conquered and occupied the country. The flourishing

Belgian arms industry in and around Liège had to devote itself to other tasks than the manufacture of luxury weapons and the royal Belgian's gift had to wait. Charles joined the resistance and spent the war undetected on a farm in Spa. A few hard years later, Belgium experienced the last German offensive in the Ardennes. The provisional government installed Charles as Prince Regent in 1944, and his gift was finally completed by Lebeau-

Courally: a pair of fine sidelock double barreled shotguns for the French General Charles de Gaulle. The shotguns were masterpieces of craftsmanship and the one illustrated here, serial number 43041, is number 2 of the pair that were given to the French general. De Gaulle (photo right) in fact used the shotguns to stalk the feathered and furred inhabitants of France in his meager spare time.

Although it is far from the more ornately decorated guns produced by Lebeau-Courally, this 12 gauge SxS sidelock shotgun, a gift of royalty, was owned and used by the President of France. It has two 28.4 inch (72cm) long demiblock barrels with a concave rib, third tumbler, and ¼ and ¾ chokes. It has a bright

breech, a non-automatic sliding tang safety with gold inlaid "S", double triggers with blued tangs, and gas release slots at butt plate. It has a striking grained stock with drops, a straight diamond shaped grip, fine Scottish checkering and the fore-end has an Anson push-rod. The borders of the white side plates are decorated with restrained floral engraving and sparse mid-arch arabesques. Other metal parts also have engraved ornamentation. The gun is signed "Capece" on the trigger guard, from Belgian master engraver Rocco Capece. There is an inset golden medallion with model name "The Standard Pigeon Gun" and an engraved dove, and a golden stock monogram plate. The shotgun comes with the original manufacturer's canvas covered case with trade label and manufacturer's certificate. It was offered at a March 2022 auction by Joh. Springers Erben of Vienna, Austria with a starting price of 10,000 euros.

Liege has been the gun manufacturing center of Belgium since the 16th century. During the 19th century, the number of firearms manufacturers in Liège increased steadily. From 36 in 1816 they grew to 97 in 1856 and to 177 in 1884. One of the smaller gunmakers was August Lebeau, who established his workshop in 1865, offering revolvers and high quality hunting arms. After Lebeau died in 1896, Ferdinand Courally, of St. Etienne, France, took over the firm and changed the name to Lebeau-Courally. Courally was not just a gunmaker but also an excellent promoter and he took aim at producing fine quality custom weapons for the royalty and nobility of Europe. He was successful and featured them as his customers in his catalogues and advertisements. This produced more sales. The firm of Lebeau-Courally became Royal Warrant Holder of the royal courts of Russia, Italy and Spain. (*The engraving on*



the left is from one of his catalogues. The printing on the barrel says that the company is of the courts of "RUSSIE, D'ESPAGNE, ET D'ITALIE.") Courally retired and sold the company in 1919 and although it has gone through a number of different owners, Lebeau-Courally has always produced high quality rifles and shotguns. Today Lebeau-Courally offers fine custom firearms made in Liege, as well as a wide range of fine Swiss-made watches.

HENRY .45-70 SAFETY RECALL NOTICE

Henry Repeating Arms recently discovered a safety issue affecting certain model **H010G** series lever action .45-70 Gov't rifles manufactured during the period from December 14, 2022, through January 11, 2023. Henry is voluntarily initiating a recall to protect the safety of its customers. Your firearm is not subject to this recall if you obtained your rifle before December 2022



To prevent the possibility of death or serious personal injury, you should immediately stop using all Henry Repeating Arms lever action .45-70 rifles and not load or fire them until determining whether the rifle is subject to this recall.

The models affected by this recall are: H010G, H010GAW, H010GAWP, H010GCC, H010X, and H024-4570.

Under certain conditions, it is possible that some of these rifles may unintentionally discharge without the trigger being pulled if the hammer is released or dropped from the cocked position. Henry has identified the cause of the issue as firing pins that may not meet specifications and is replacing the firing pin to correct it.

For more information and to determine whether your specific Henry lever action .45-70 is subject to this recall, go to the Henry website at https://www.henryusa.com/recall. Enter the serial number of your rifle in the box at the bottom of the page, ensuring you've entered the correct letters and numbers, then click on the "LOOK UP" button. If your firearm is not affected, no further action is needed. If your firearm is affected, continue filling out the form to submit a recall service request. Once approved, you will receive a prepaid return shipping label and further instructions. After your firearm is serviced with a replacement firing pin, Henry Repeating Arms will send a \$50 eGift card for HenryPride.com.

The last time Henry issued a recall notice was in July 2020. That was a combination recall and free upgrade for **H015** models of single shot rifles and shotguns.



Under certain conditions, it is possible that some of these rifles and shotguns may discharge without the trigger being pulled if the hammer is partially cocked and released. Henry identified the cause of the issue, and will correct it by replacing various components of the fire control system.

Henry Repeating Arms also implemented a complimentary upgrade for all firearms affected by this safety recall. This upgrade involves a replacement of the trigger guard, hammer, and hammer spring. This design change to improve and reduce the trigger pull has already been incorporated into all **H015** rifle and shotgun models manufactured in 2020, and will be made to your rifle or shotgun free of charge.



FEBRUARY SHOW-N-TELL

Member 1 brought in a Hungarian P9RK pistol (right) manufactured by FEG in Hungary. The FEG Company of Hungary made excellent unlicensed copies of the famous Browning High Power in 9x19 Parabellum. It also made a modified version for those preferring a Double Action firearm. The P9RK is the compact version of the longer and higher capacity P9R. While it's referred to as a "Double Action Browning High Power," it's more akin to a cross between the Browning and the Smith & Wesson Model 59. It has a Decocker mounted on the left side of the slide, and a magazine capacity of 14 rounds (it can also take standard 13 round Browning High Power magazines). The P9R was adopted by the Hungarian police in 1993, and was later adopted by the Hungarian military as the P9RC. This pistol was also made under contract by FEG for Mauser as the Model 90DA. These are marked with the Mauser Banner on the slide, and were proffed by Mauser. It was also marketed in the U.S. under the name MBK-9HP. Member 1 acquired this example from Sports Authority in Fairfax, VA in 1994.





Member 1 also shared a Swedish 1896 Mauser infantry long rifle (left). With an overall length of 50 inches and 28.5-inch barrel, this Mauser design had a 5 round capacity and is chambered in 6.5x55 Swede. Made in 1921 at the Carl Gustav factory, it features a decocking piece on back of the bolt to slowly let the firing pin forward. The M1896 was eventually replaced in 1938 by the M1938 short rifle. Many existing M1896s were shortened to the new military standard and redesignated the M96/38.

Member 2 brought in Inglis manufactured WWII Chinese contract Mark 1* Hi Power (at right) with shoulder stock/holster. It is important to note that the BATFE has listed an explicit exemption for this combination (pistol and original period stock) as a Curio & Relic – therefore, it is NOT a short barreled rifle, nor is it regulated under the National Firearms Act (NFA).





Member 3 shared his 1991-made rather handsome 2-Tone Hi-Power (*left*). A prior owner had this example tricked out with a Tru-Glo front sight and had the magazine disconnect removed (so it will fire without a magazine in it). It has also has had a trigger job and features a skeleton hammer.



Member 4 brought a reproduction Germanic flintlock Jaeger rifle (*above*), representative of early pre-Revolution German Gunmakers in Pennsylvania (circa 1740-1760).

Background: The Germanic Jaeger was a short-barreled (22-32") heavy-caliber hunting rifle from the area that is now Germany. The design was adapted for military and used by the Hessian regiments allied to the British in the Revolution, which in turn inspired the British Model of 1776 rifle. It was is an essential element and early predecessor to the uniquely American rifles known as Pennsylvania or later as Kentucky Rifles or longrifles.

In 1741 Count Nicolaus Zinzendorf traveled to Pennsylvania, where the Moravians founded Bethlehem. The town grew rapidly from only 131 settlers in 1741 to more than 1,200 Moravians in Bethlehem and the surrounding region by 1753. Other distinctively Moravian communities followed, including Christiansbrunn (Christians Spring) in Pennsylvania. Christians Spring was where the Moravians established a communal industrial center that included a group of Moravian gunsmiths from the area of Suhl and Saxony. These highly-skilled gunsmiths later became a source for militia rifles and gunsmithing that supported the Colonials during the American Revolution. As the Eastern frontier moved west, the gunsmiths followed the demand and the later rifles became longer and used a lighter caliber to enhance range and also reduce the amount of lead used for the balls.

This example is iron-mounted with a curly maple stock. The barrel is .58 caliber, swamped (which means externally tapered down from breech to about 2/3rds of the way the muzzle, then flares again from that point to the muzzle), and uses round bottomed rifling. The early Germanic lock is fired by a double set trigger that must be set to be cocked. German Jaegers were primarily owned by wealthy nobility and landowners in Europe, and as such many were ornately engraved and inlayed, often using horn, brass, or silver nosepieces. As representative of a working man's rifle in America, this piece lacks a patch box and nosepiece, and already shows the lengthening of the barrel to 33". This example was made in 2021.




Member 5 shared two Hi-Powers. The first was his 1982 production Hi-Power with a high polish nickel plated finish (*at left*).

Member 5's second Hi-Power (*below*) was actually a SA35 – a new Springfield Armory Hi-Power clone. This example was picked up new from Town Police Supply at a Richmond gun show.



Member 6 (*right*) brought in a beautifully engraved Renaissance Hi-Power (commemorating the "renaissance of the High Power pistol"), complete with a leather and velvet case. It features Mother of Pearl grips and a gold-plated trigger. Member 6 acquired this exceptional piece at Potomac Arms in Alexandria during their going out of business sale in September 2006, paying \$750. Well done, sir!





Member 7 shared his M1904 Portuguese Mauser rifle (*left*). Designed by Portuguese Army Infantry Officer José Alberto Vergueiro, the M1904 is also called the Mauser-Vergueiro in honor of its designer. Chambered in 6.5x58 Vergueiro and manufactured by DWM in Berlin, many were subsequently converted to 8mm Mauser during 1937-1939 after that caliber was adopted as the Portuguese

standard. The M1904/39 introduced a tangent rear sight, a somewhat chunky front sight, and center leg to reinforce the stock. This example has all matching serial numbers!

Member 8 brought in a Trailblazer LifeCard pistol (*right*). This .22LR single shot folds up to look like a cell phone or other small device (*see below*). It features a tip-up single shot barrel with pull-back striker. The trigger is exposed only when gun is opened into the firing position. It is only ½ inch thick and weighs a mere 7 ounces!

It is a regular title-1 firearm, NOT an Any Other Weapon (AOW) as it can be easily recognized as a gun when in the open position and ready for firing.




Member 9 shared his Argentine HP, circa 1980 (*graciously held by Member 8 at left*). This example has been modified with adjustable rear sight, white front sight, and Pachmayer grips.

Member 9 also brought in two HP holsters (right) – the one the right appears to British and the on the left is Canadian with provenance to an Army Special Forces soldier who used it to carry his Hi-Power in Vietnam.



Member 10 shared two Hi-Powers. The first is a Browning P35 made in 1969 (*at right*). It has a parkerized finish (not a standard finish for the Browning) and has factory rubber grips. Member 10 purchased this pistol in 1998 for \$270.



The second "Hi-Power" was a Hungarian P9R manufactured by Fegyver es Gazkeszulekgyar (FEG). This double action/single action was imported into the United States in fairly large numbers from the mid-1980s to the late 1990s. There were three models in the series:


- The P9R, a full-size model (at left)
- The P9RK, a short model with a finger-grip style front trigger guard
- The P9RA, a lightweight, aluminumframed version which was imported in relatively small numbers

This example came to Member 10 as a Christmas gift in 1992.



During WWII, British Commandos contracted for a small number of heavily modified Lee-Enfield Mk III* rifles. Using modified Thompson SMG barrels chambered in .45 ACP and utilizing M1911 pistol magazines, these bolt action carbines with an integral suppressor were named "De Lisle Carbines" after its inventor, William Godfray de Lisle. Highly effective, approximately 147 were produced during the war and they are reputed to have been involved in the assassination of at least two senior German officers during Operation Jedburgh in 1944. Member 11 (a relatively new member and attending his first meeting) shared his custom Lee-Enfield conversion (*above*). Purchased as a receiver only, it was upgraded with a caliber convesion kit from Rhineland Arms and uses a Dead Air muzzle device for mounting a suppressor. While not a direct reproduction, it is his "poor man's De Lisle carbine."

Member 12 shared a different FN product, this one an FN SCAR 20S308 with Surefire military contract suppressor. Member 12 bought this after the NRA Annual Meetings in Indianapolis, IN in 2019 using a Brownell's 20% off coupon. This rifle mounts a Leupold scope and has a Geissele trigger installed.

Member 13 (*right*) brought in two Canadian Inglis Hi-Powers made in 1942-1944. One is in very nice condition with an original stock. The other one has a



rankacment stack with it that has a hit of an

replacement stock with it that has a bit of an odd angle to it (*left*) – compare this one to the stock shown on page 19. I am not sure you can get a meaningful cheek weld on this stock!

Member 15 shared his Argentine Army Hi-Power (*above*) that had been produced in Argentina under license from FN. Argentine Hi-Powers were manufactured by Direccion General Fabrications Militaries (FM) at their arms factory, Fabrica Armas Portatiles Domingo F. Matheu in Rosario, under license from 1969-1989 (and possibly surreptitiously after the license expired as well). They are identifiable by the proof mark on the right side of the trigger guard. This example came with an unusual holster.


