At this point we are going to have to cancel all member meetings through October. Currently the NRA building is closed to everyone except essential employees. That being said, we do not have a meeting place for September or October and have no idea when the

The other issue is that they are currently separating tables by 8 feet from individual vendors. That may financially preclude us from having a show by decreasing the size by a third to half. I really want to maintain the integrity and the quality of the VGCA gun show. Much more to come on this subject in the next few months.

♦ August Business Meeting **♦**

♦ August Business: Although we have not had a membership meeting since February and thus there is no information from a membership meeting to be passed along here, the VGCA officers, directors, and committee chairmen *did* meet in August (practicing appropriate social distancing, of course). The following decisions were reached at that meeting:

- Due to COVID-19 quarantine restrictions on public gatherings, most VGCA events (including a field trip, two spring gun shows, and four membership meetings so far) have been canceled in 2020. With little prospect for things to return to normal before the end of the year, it was decided that all annual membership dues for 2020 will be extended through 2021. In other words, if you are a VGCA annual member in good standing and paid your dues for 2020 or you're a new annual member joining the VGCA in 2020 your 2020 dues will be automatically applied to 2021. See the NOTICE on page 3 of this newsletter.
- The NRA facilities remain closed to all but essential personnel. Most of the NRA staff has been furloughed. The NRA conference is thus not available for meetings, even at reduced capacity. Virginia still has quaratine restrictions on public gatherings. Given these facts and that COVID-19 is especially deadly for older individuals, the VGCA Executive
 this year. We may try to have a "virtual" membership meeting via one of the computer-based software platforms in October stand-by for further details to be published on our website or sent out by Constant Contact.
- The decision whether to cancel the November VGCA gun show will be made a VGCA Executive Committee meeting in September.
- Officer elections for VGCA President, Vice President, Secretary, and Treasurer were supposed to be held in May of this year, following a call for candidate nominees at the April membership meeting. As the April meeting was canceled and we could not take nominations from the floor, the <a href="Executive Committee voted unanimously to extend the terms of the currently sitting officers through May 2021 (all officers agreed to remain in place for this longer term). In May 2021, we will hold elections for both the officers and the three VGCA director positions. The officers elected in 2021 will only serve 1-year terms (the Directors elected next year will serve their full 2-year terms), and with officer elections taking place again in 2022, we will be back on track alternating our officer elections with the director elections.</p>

Next Membership Meeting: As noted above, the NRA facilities remain closed to all but essential personnel. With no place to meet and COVID-19 quarantine restrictions on public gatherings still in place, all VGCA membership meetings between now and the end of the year have been canceled. As of now, our next scheduled membership meeting is not planned until January 2021. If the situation changes, the VGCA Executive Committee agreed to re-address this decision. ○ NOTICE: All VGCA 2020 Annual Memberships Extended through 2021

As we all know, 2020 has been a general mess for everyone. VGCA had to cancel many of our planned 2020 Association activities due to the COVID-19 Pandemic. We postponed a field trip to the Armour Museum in Danville, VA in April and canceled two gun shows in March and May 2020, due to Virginia State and Prince William County Public Health Directives. We face uncertainty regarding the November 2020 gun show.

VGCA also canceled the April, May, June and August Membership Meetings at the NRA/NFM, and had to postpone the May 2020 election of new Officers. The result is only two member activities have taken place in 2020.

As of July 1st, the new gun restrictions are now law in Virginia. Two of these laws in particular will have a negative impact on our members and gun shows. They are the Universal Background Check restrictions on private sales and the One Handgun a Month law.

The One Handgun a Month law means just that, a person can only purchase one handgun per month. There are several exceptions to this law: police, CCW holders, and Curio and Relic (C&R) holders (on applicable items). An individual who does not meet any of these exemptions may also apply to the state for permission to buy more than one handgun.

The Universal Background Check law states that all private sales must go through the background check process. There are several exemptions to this law but the two exemptions that will be most relevant to our membership will be the Antique gun and C&R eligible gun exemptions.

"Antique" is broadly defined by the State in *Chapter 1111 Section 18.2-308.2.2 Subsection F* as:

- "1. Any firearm (<u>including</u> any firearm with a matchlock, flintlock, percussion cap, or similar type of ignition system) manufactured in or before 1898;
- 2. Any replica of any firearm described in subdivision 1 of this definition if such replica (i) is not designed or redesigned for using rimfire or conventional centerfire fixed ammunition or (ii) uses rimfire or conventional centerfire fixed ammunition that is no longer manufactured in the United States and that is not readily available in the ordinary channels of commercial trade;
- 3. Any muzzle-loading rifle, muzzle-loading shotgun, or muzzle-loading pistol that is designed to use black powder, or a black powder substitute, and that cannot use fixed ammunition. For purposes of this subdivision, the term "antique firearm" shall not include any weapon that incorporates a firearm frame or receiver, any firearm that is converted into a muzzle-loading weapon, or any muzzle-loading weapon that can be readily converted to fire fixed ammunition by replacing the barrel, bolt, breech-block, or any combination thereof; or
- 4. Any curio or relic as defined in this subsection."

The wording in the Virginia "antiques" definition was not changed and is basically the same as the definition in Federal law, 18 U.S.C. Section 921(A)(16), except for number 4 regarding curios and relics. The Federal definition of "antiques" does not mention C&Rs.

The Virginia definition of Curios and Relics in *Chapter 1111 Section 18.2-308.2.2 Subsection F* is potentially more problematic and the exemptions may be more ambiguous. To qualify (as per the State) the item must have a special collector interest and fall under one of the following categories: 1) Manufactured at least 50 years ago but which use rimfire or conventional centerfire fixed ammunition that is no longer manufactured in the United States and that is not readily available in the ordinary channels of commercial trade. (The Japanese Nambu would fall under this category); 2) A firearm that has been certified by the curator of a municipal, state, or federal museum that exhibits firearms to be a curio or relic of museum interest. This is a rather broad exemption as the burden will be on the State to prove that a firearm does not fall under this category; 3) Any firearm that derives a substantial part of its monetary value from the fact that it novel, rare, bizarre, or because of its association with historical figure, period, or event. The primary qualifier for this category will be the value of the firearm derived from it being "collectible" as opposed to a similar firearm in current production or the fact that the firearm is only available through collector channels.

This subsection, also remained unchanged in the Virginia law. The potential problem is that the Federal definition of C&R in 27 CFR 478.11 (which the Bureau of Alcohol, Tobacco and Firearms goes by) does not currently have the wording regarding ammunition that is in the Virginia statute. This wording was previously in the Virginia law but until now appears to have been ignored in deference to the Federal law. This conflict with Federal law was not an issue before but it could become problematic.

None of the above is intended to be legal advice and given the current administration in Richmond extreme care should be taken with any firearms sale or purchase.

CMP UPDATE

PURCHASE ELIGIBILTY REQUIRMENTS

By law, the Civilian Marksmanship Program (CMP) can sell surplus military firearms, ammunition, parts and other items only to members of CMP affiliated clubs who are also U.S. citizens, over 18 years of age (over 21 years of age in some states) and who are legally eligible to purchase a firearm. Your membership in the VGCA allows you to purchase rifles, parts and ammunition from the CMP because the VGCA is a CMP affiliated club. This is just one benefit of being a member of the VGCA. The VGCA affiliate number is **026160**.

To be eligible to purchase a rifle from CMP, you must provide the following:

Proof of U.S. Citizenship

You must provide a copy of a U.S. birth certificate, an enhanced driver's license, passport, proof of naturalization, or any official government document (when using a military ID to prove citizenship, must be an E5 or above) that shows birth in the U.S. or states citizenship as U.S. Law enforcement status if you are a Federal officer.

Proof of Age

You must provide proof of age. Usually proof of citizenship also provides proof of age. In those cases where it may not, a driver's license is sufficient.



Membership in CMP-Affiliated Organization

You must provide a photocopy of your current VGCA membership card or other proof of membership. This requirement cannot be waived.

Note: Club membership IS required for purchase of rifles, parts, and ammunition. Club membership is NOT required for instructional publications or videos or CMP memorabilia.

Marksmanship or Other Firearms-Related Activity

You must provide proof of participation in a marksmanship-related activity or otherwise show familiarity with the safe handling of firearms and range procedures. Your marksmanship related activity does not have to be with highpower rifles; it can be with smallbore rifles, pistols, air guns or shotguns.

No proof of marksmanship is required if over age 60. Proof of club membership and citizenship is required for all ages.

NOTE: Proof of marksmanship activity is not required for purchase of ammunition, parts, publications or memorabilia.

Proof of marksmanship participation can be provided by documenting any of the following:

- Current or past military service.
- Current or past law enforcement service
- Participation in a rifle, pistol, air gun or shotgun competition (provide copy of results bulletin).
- Completion of a marksmanship clinic that included live fire training (provide a copy of the certificate of completion or a statement from the instructor). Visit the CMP website to find an upcoming CMP sanctioned clinic or match.
- Distinguished, Instructor, or Coach status.
- Concealed Carry License.
- Firearms Owner Identification Cards that included live fire training. FFL or C&R license.
- Completion of a Hunter Safety Course that included live fire training.
- Certification from range or club official or law enforcement officer witnessing shooting activity.
 Complete the CMP Marksmanship Form (available from the CMP website) to certify your range firing and the required marksmanship related activity for an individual to purchase from the CMP.

Legal Eligibility to Purchase a Firearm

The information you supply on your application will be submitted by the CMP to the FBI National Instant Criminal Check System (NICS) to verify you are not prohibited by Federal, State or Local law from acquiring or possessing a rifle. Your signature on the Purchaser Certification portion of the purchase application authorizes the CMP to initiate the NICS check and authorizes the FBI to inform CMP of the result. You will need to provide a signed and notarized <u>form</u>



2A for any item purchased. This form can be downloaded from the CMP website.

State or Locality Requirements

If your State or locality requires you to first obtain a certificate, license, permit, or Firearms Owner ID card in order to possess or receive a rifle, you must enclose a photocopy of your certificate, license, permit, or card with the application for purchase.

According to the CMP website there are currently no additional requirements for Maryland or Virginia. However, the CMP website does list additional requirements for residents of Washington, DC. According to the CMP website, for rifle shipments the customer will need to register the serial number with the Police Department once provided and send the CMP a copy of the PD219 form before it can ship a rifle. For ammunition sales, the DC resident will need to contact the Police Department and send the CMP a copy of the PD 219 form before the CMP ships the ammunition.

GUNS OF DISTINCTION

A PAIR OF AUSTRIAN FLINTLOCK SADDLE PISTOLS

Johann Joseph Pauer (Bauer) was a prominent gunmaker in Vienna, Austria between 1708 and 1744. In 1744 he became master of the gunmaker's guild. He manufactured this matched pair of exquisite flintlock saddle pistols in about 1730. The .55 caliber (14mm) smoothbore pistols, numbered "1" and "2" on the tangs, are 20.5" (52cm) long. The 13.4" long rose Damascus barrels have octagonal breeches and taper to round muzzles. They are decorated with inlaid silver wire scroll design and the breech ends and muzzles are decorated with silver wire inlay and gold-washed maker's marks.



The flat lock plates are decorated with deep relief engravings of Mars, the god of war, surrounded by trophies. They are signed "J. Pauer in Viennan." The guns have chiseled cocks and the full walnut stocks are decorated with ornate rocaille and scroll carvings and dark horn tips. The fire-gilt furniture has deep relief engraving and the walnut ramrods have horn tips.



Saddle pistols were carried on horseback in holsters secured to the pommel of a saddle. Highly decorated pairs like these were often the property of noblemen, wealthy persons and high-ranking officers.

A TRIP TO THE MUSEUM:

BATTLE OF THE BULGE MUSEUM SURVEY

The Battle of the Bulge, which took place from December 16, 1944 to January 25, 1945. was one of the bloodiest of the battles of World War II. Three German armies attacked a weakly defended section of the allied line, advancing through the densely forested Ardennes region of eastern Belgium, northeast France, and Luxembourg. It was a desperate effort to stop Allied use of the Belgian port of Antwerp and to split the Allied lines, allowing the Germans to encircle and destroy four Allied armies. American forces bore the brunt of the surprise attack. The "Bulge" was the largest and bloodiest single battle fought by the United States in World War II and the third-deadliest

campaign in American history. Out of a total of 610,000 U.S. troops engaged in the battle, 89,500 became casualties out of which some 19,000 were killed. The German army also paid a heavy price. Between 63,222 and 98,000 men were killed, missing, wounded in action, or captured out of the 450,000 German troops engaged with the loss of massive quantities of vehicles and equipment. 112,000 British troops took part in the battle with 1,408 casualties. And the civilian population suffered horrendous casualties with entire towns and villages being utterly destroyed.

It is no wonder then that after such a traumatic experience that many memorials and museums dedicated to the battle can be found in the region. Many of the museums started as small collections of vehicles, uniforms, arms and equipment – much of which was abandoned debris found on the battlefield. Many of the museums grew over the years and are worth a couple of hours to tour. Although most of the museums are in Belgium, Luxembourg has its share. Although they are not "American" museums, per se, one thing that they have in common is praise for the Americans as liberators and defenders and recognition of American sacrifices.

The following is a brief survey of 12 Battle of the Bulge Museums and one Memorial in Belgium and Luxembourg. One thing to keep in mind is that the museum rules, days, hours, fees, entrance requirements and tours will probably change due to the Covid-19 pandemic. So contact the museum before visiting.

Bastogne Barracks - Bastogne

Royal Museum of the Armed Forces and Military History

Bastogne Barracks is a Belgian Military Museum and Interpretation Center of the Second World War with a focus on the Battle of the Bulge. There is also an exhibit dedicated to the Gulf War. A large part is dedicated to the defense of Bastogne. On December 19, 1944 Brigadier General Anthony McAuliffe and the 101st Airborne Division arrived in Bastogne and he established his headquarters at the Barracks. On December 22 he answered "Nuts" to a German demand to surrender. The basement headquarters where he uttered his famous answer is just one in a number of powerful exhibits. Attached to the museum is a "Vehicle Restoration Center" containing dozens World War II tanks and armored vehicles. A tour of the museum takes about two hours.

Days and hours vary depending on the time of the year. Admission is free.

Bastogne War Museum, Bastogne



Located close to the famous Mardasson Memorial, the Bastogne War Museum is the principal memorial dedicated to the Second World War in the Ardennes and Belgium. It offers a particular emphasis on the Battle of the Bulge. It contains many displays, uniforms, weapons, vehicles and other artefacts – about 400 exhibited objects on 1,600 square meters. Signage and audio guides are in 4 languages: English, French, Dutch and German. Besides the displays, the museum offers four story lines of people who experienced the Battle of Bastogne: an American soldier, a German officer, a

member of the local resistance and a schoolboy. The visitor hears their stories though an audio guide that automatically plays the soundtrack for the display the visitor is looking at or the multi-media experience.

Along the route though the museum there are 3 multi-media rooms. In one the visitor is in a foxhole in the Ardennes forest, it's dark and foggy. In the last multi-media experience the visitor is in a cafe in Bastogne when the German shelling starts. When you include a visit to the nearby (100 m) Mardasson Memorial you can easily spend 3 to 4 hours. The museum has a gift shop and restaurant. The museum is located at:

Baugnez 44 Historical Center, Malmedy

Recently modernized and expanded, the theme of this museum is the Battle of the Bulge, with a particular focus on, and dedication to, the Malmedy Massacre. The museum is located close to the road crossing where SS troops belonging to Kampfgruppe Peiper massacred at least 84 American prisoners from the 285th Field Artillery Observation Battalion. Baugnez 44 is not a big museum, but certainly well worth a visit. Like many "Bulge" museums it is known for its dioramas as well as static displays. Although it is not a large museum, it does have a gift shop and a restaurant and you can easily spend up to 2 hours at this place

December 1944 Museum, La Gleize



This is a small village museum about the Battle of the Bulge with a focus on the fierce fighting around the La Gleize-Stoumont area where Kampfgruppe Peiper, spearhead of the 1st SS Panzer Division bogged down and was forced to retreat. Reconstructed scenes of the battles bring history to life in 17 dioramas featuring 85 fully equipped soldiers from both the Axis and the Allies. Many weapons, uniforms, vehicles and other equipment are displayed, as well as photos, maps and other documents from the devastating combat around the village La Gleize. One of the featured vehicles of the museum is one of the few surviving German Tiger II tanks, also known as the King Tiger (or Königstiger), which is standing at the entrance to the museum. It is one of the 136 tanks and armored vehicles that Kampfgruppe

Peiper abandoned when it left La Gleize and retreated back to Germany. The Tiger II (number 213) was disabled defending the nearby Werimont Farm. After the war the local innkeeper's wife bought it for a bottle of cognac from salvaging GIs by, thus saving it for posterity.

101st Airborne Museum, Bastogne

The 101st Airborne Museum is located in the former officers mess building of the Belgium Army; "Le Mess Museum". During the German occupation during World War II it served the Germans to house Wehrmacht NCO's and after the liberation it was a Red Cross hospital. The museum was established a few years ago to remember the role of the 101st Airborne Division in the defense of Bastogne. The Battle of the Bulge comes to life in unique diorama and static displays with realistic looking mannequins. And of course there is a large collection of original items of this dramatic battle. The museum also offers a historical briefing about the battle for groups.

La Roche Museum of the Battle of the Ardennes, La Roche-en-Ardenne

The privately-run Battle of the Ardennes Museum is the brainchild of Michel Bouillon and his son Gilles. What started off as a modest hobby collecting artifacts relating to the battle grew until the two men had accumulated so many objects that in 1993 they decided to open a museum. The theme of this museum is the Battle of the Bulge from the British perspective, with a strong focus on the 51st Highland Division. La Roche Museum covers about 1,500 square meters on three floors. The displays contain more than 120 mannequins in uniform and 20 military vehicles. The museum also houses an



important collection of light and heavy arms, personal objects and equipment found on the battlefield.

The Weapons Room alone contains some 90 rifles, sidearms and other weapons, as well as the famous 'Enigma' cypher machines of Polish origin...Dioramas depict various episodes of the Battle of the Bulge, especially around La Roche-en-Ardenne. Today it is a pleasant place with many cafes and restaurants, but in 1945 it was almost completely destroyed during the German attack and then the allied counterattack. A visit to the museum can last about two hours.

Remember Museum 39-45, Thimister-Clermont

The Remember Museum 39-45 is a private museum that was founded by Marcel Schmetz and his wife Mathilde to commemorate the liberation of Belgium by American soldiers and as a memorial to the fallen GIs. In the words of the museum's founder, "The museum strives to serve as the testimony of our gratefulness towards all the G.I.s who, at the risk of their lives, gave us our freedom back." In December 1944 some 110 American soldiers of the 26th Regiment, 1st Infantry Division were stationed at the Schmetz family farm to rest. Marcel was about 7 years old at the time. When the German



offensive began the "Big Red One" troops quickly moved up to the front in the Ardennes, leaving equipment and personal belongings behind. This material was saved by the Schmetz family and, supplemented by donations from veterans, forms the core of the museum's collection. The collection now includes an M4 Sherman, a M10 tank destroyer, a WW2 era Citroën Traction Avant, several dioramas, weapons, equipment and lots of photos. The story behind each personal item brings history, and the soldiers' lives, into the limelight. The museum is 2 miles from the Military Cemetery Henri-Chapelle, where 7,992 American soldiers are buried.

Museum of the Battle of the Bulge, Clervaux

Tucked away in a corner of the historic Chateaux Clervaux, the Museum of the Battle of the Bulge in Clervaux illustrates the course of the Battle of the Bulge through documents and dioramas, military uniforms, numerous artifacts and many authentic weapons. Besides telling the story of the battle, the small museum keeps alive the memory of the Americans who liberated Luxembourg. It is far from being

one of the modern glitzy, interactive museums, and is more a collection than a curated display with extensive signage but it does have a heart. There is a lack of organization, it is split over three floors and signage could be better but it is worth a 30-45 minute visit, if only to see the numerous artifacts and weapons. The U.S. Sherman M4A3 of Company B, 2nd Tank Battalion, 9th Armored Division at the museum's entrance is the only known surviving combat vehicle of that division. It stands not far from where it was put out of action on December 17, 1944 while defending the castle during the German attack.

Truschbaum Museum at Camp Elsenborn

Camp Elsenborn is an active Belgian Army post and training area and the Belgian Army regularly holds exercises there. The Truschbaum Museum is on the base and access to the museum is currently restricted and only by appointment. The museum covers the history of Camp Elsenborn, which was established by the Prussian Army in 1894, as well as covering the Belgian Army in the First and Second World Wars. The Battle of the Bulge is a major focus of the exhibits, with many original maps, documents, equipment, weapons and relics. One part of this story is the fierce 10-day long struggle for Elsenborn Ridge



in which the 2^{nd} Infantry Division and the "battle babies" of the 99^{th} Infantry Division distinguished themselves by stopping the German advance in the north. Exhibits include armored fighting vehicles and artillery as well as a large number of realistic dioramas. There is a recreated First World War trench. Reservation by phone - +32 80 44 21 05. National Museum of Military History, Diekirch



This impressive museum is Luxembourg's official military museum. Located in a former brewery the museum has over 3,000 square meters of exhibition space that is filled with dioramas, vehicles, artillery, crew-served and individual weapons, equipment, uniforms, documents and relics. The museum is dedicated to World War 2 with a particular focus on the Battle of the Bulge. The main display area contains a small assortment of tanks, large caliber weapons, wheeled and tracked vehicles of both German and American origin. All of the display vehicles have been restored with attention to detail and authenticity. The museum is also packed to the rafters with Allied and German ordnance

of every kind, some of which are quite rare. In fact, the museum has one of the best collections of World War 2 weapons in Europe. The museum, of course, has excellent dioramas depicting various aspects and incidents in the Battle of the Bulge. Many of the dioramas are so well done that they make you feel as if you were actually there. Particularly noteworthy is the large diorama of a platoon of the US 5th Army making a nighttime crossing of the Sauer River into Germany.

For an in-depth review of this museum, read the exceptional article by Bernie Breighner in the special issue of the VGCA Newsletter. The museum located about 35 km northeast of Luxembourg City. It is normally open from 10:00AM-6:00PM Tuesday thru Sunday, closed Mondays. Admission is 5 Euros for adults.

General Patton Memorial Museum, Ettelbruck



This small two-story local museum is a tribute to General George S. Patton Jr., commander of the Third US Army whose troops liberated the town of Ettelbruck, Luxembourg on December 25, 1944. More than 1,000 photographs, documents and numerous authentic artifacts provide a remarkably in-depth view of the German occupation of Luxembourg during the war and the special place General Patton holds in the hearts of the inhabitants. The exhibition tells the general's life story, displays military equipment and describes aerial warfare over Luxembourg. There are numerous weapons and pieces of equipment discovered on the Ardennes battlefield. Patton is buried in the American cemetery in Hamm on the outskirts of Luxembourg City.

Bulge Relics Museum, Joubieval

This private museum was created only a few years ago by Jean-François Noirhomme. According to Noirhomme, "We were born in the Belgian Ardennes, one of the worst areas of the Second World War, where the so-called "Battle of the Bulge" took place. We have always been interested in the history of our region, where our parents and grandparents experienced that dreadful winter 1944-1945." Noirhomme started collecting artifacts and relics from the battle in 1984 and his collection soon outgrew his house, basement and garage. The museum is well hidden and the outside belies the treasures within. The three floors hold a veritable cornucopia of US and German weaponry, uniforms, helmets, vehicles, various pieces of equipment, some of it rare and unique. Many of the US items are from the 83rd Infantry Division and the 3rd Armored Division and were found on the sites of the Vielsalm, Lierneux and at the Baraque de Fraiture crossroads battlefields. The entrance fee is 5 euros and it is best to call ahead and make a reservation.

Mardasson Memorial

The Mardasson Memorial is a monument from the Belgian people to the United States honoring the memory of the American soldiers who were killed, wounded or missing during the Battle of the Bulge. At the center of the Memorial, a stone bears the inscription in Latin "The Belgian people remember their American Liberators." Located near Bastogne, and designed by the architect Georges Dedoyard, the memorial is a 39 foot tall monument in the shape of a five-pointed American star with 102 foot long sides surrounding a 66 foot wide atrium. The inner walls are covered with ten passages carved in stone commemorating the battle. Insignia of most



participating US units are shown on the walls, representing the 76,890 killed and wounded during the December 1944–January 1945 German "Watch on the Rhine" offensive, better known to us as the Battle of the Bulge. Below the structure is a crypt with three altars – one each for Protestant, Catholic and Jewish services – carved and decorated with mosaics by famed French artist Fernand Léger. The Mardasson Memorial is only about 100 meters from the Bastogne War Museum.
