June Presentation – The Schmidt-Rubin Rifle and Ammunition



VGCA member Tor Johnson (above) graciously shared his knowledge of the Schmidt-Rubin family of rifles and associated ammunition at the June VGCA Membership Meeting. The story of Swiss military cartridge rifles goes back to the Vetterli, a bolt action, tube-magazine rifle that served as the primary infantry weapon of Switzerland from 1869-1889. It was chambered in the .41 Swiss, a black powder rimfire cartridge that actually measured 10.4x38mm. Typical of military calibers of the era, it was rendered obsolete by the invention of smokeless powder in 1884. Small arms ammunition development continued with the creation of jacketed bullets designed to better handle the increased velocities genereated by smokeless powder. Seeing the handwriting on the wall, Swiss military authorities began looking for a new military cartridge and a new rifle design to chamber it in the mid-1880s. Lieutenant Colonel Eduard Rubin, a Swiss mechanical engineer who had developed a Full Metal Jacket (FMJ) bullet in 1882, came up with several bottlenecked, rimless centerfire designs in various calibers between 7mm and 8mm. Simultaneously with Rubin's work, Colonel Rudolf Schmidt was designing a new rifle that would ultimately become the Model 1889. A straight-pull design similar in operation to the later U.S. Model 1895 Lee or the Canadian Ross, the Model 1889 featured a 12-round box magazine with a cut-off and a bolt handle made from plastic. The caliber selected was the 7.5x53.5mm using semi-smokeless powder launching a 211 grain paper-patched, copper-coated, soft iron core round nose bullet to about double the range of the .41 Swiss. This was designated the Gewehr Patrone 90 (GP90). The new rifle and ammunition combination became known as the Schmidt-Rubin.

In 1896 both the rifle and cartridge were improved and the Model 1896 rifle and carbine were fielded. One of the improvements to the rifle was moving the bolt locking lugs from the middle of the bolt to the front. Model 1889 rifles were similarly upgraded and designated the Model 1889/96. This was followed in the next year by the Model 1897 Cadet Rifle, a short single-shot rifle that fired a reduced power cartridge. The cadet rifle was interesting in that its rear sight had two separate scales – the left side was graduated for the standard GP90 ammunition while the right side was graduated for the less powerful cadet ammo (designed 7.5mm Kadettenpatrone).

The next major development was adoption of a new standard round using a completely smokeless powder charge and a 174 grain spitzer boattail bullet. A new rifle, the Model 1911, was adopted to handle this new round, designated the GP11. To prevent the more powerful ammo from being fired in the older and unmodified rifles, the case was lengthened and became the 7.5x55mm. Most Model 1896 rifles were upgraded, with differences including a new barrel, a new rear sight regulated for the new ammo, and an added pistol grip to the stock. These upgraded rifles were designated the Model 1896/11. New-built Model 1911s included both infantry rifles (the Gewehr 1911 or G11) and carbines (the Karabiner 1911 or K11).

The last major Schmidt-Rubin variant was the Karabiner 31 (K31). It served as the standard Swiss infantry rifle for three decades starting in 1933. The action/receiver was shortened, allowing the 6-round magazine to be placed immediately in front of the trigger guard. Because of the shorter action, a longer barrel was fitted that resulted in the same overall length as the K11 (*see the comparison between the K31 and K11 at right*). The K31 bolt knobs were made from metal, replacing the easily chipped/cracked plastic knobs on the earlier variants.



Tor's presntation included a review of the markings on the Schmidt-Rubins, the Nicaraguan/Israeli contract, the ZFK 55 sniper, .22 rimfire conversions, and associated bayonets and other accessories. This was another superb presentation enjoyed by all present, and if you see Tor at one of our shows or meetings, please be sure to thank him!

Upcoming Tours

The VGCA is pleased to announce that we have arranged a tour of Knight's Armament and the Institute of Military Technology Museum in Titusville, Florida, tentatively scheduled for 1-2 November, 2024. In addition, we will visit the National Museum of the Marine Corps, Triangle, Virginia, tentatively scheduled for 16 November 2024. More details, including confirmation of dates and sign-up rosters, will be provided at our membership meetings, starting in August.

In the words of Ralph Waldo Emerson, it's "It's not the destination, it's the journey". We knew going into this show we would have tough competition. We had been warned by fellow club members to expect the Ohio Gun Collectors Association to probably sweep the awards. Despite this, we were able to garner the National Firearms Museum's award for "the Spirit of the Game". While we may have had secret hopes for a silver medallion or even the award for Best Combined Arms Display, Lou and I are both pretty excited about even winning a single award! While that may not seem like a lot to some, being 26 years old, experiencing my first national competition, and winning anything felt pretty good to me! The 153rd annual NRA Membership Meetings in Dallas, Texas had 16 total clubs competing, and according to the NRA leadership one of their best turnouts. Our humble 10x10 booth had to compete with the museum quality displays from the aforementioned Ohio Gun Collectors Association, the Polish Hunting and Shooting Collectors Club, Smith and Wesson Collectors Association, and many other distinguished clubs. As stated by several club members, it's not often our club travels west of

the Mississippi River for these events. Lou and I would like to thank the VGCA for sponsoring our travel to this NRA convention.

As previously stated, this was Lou's and my first trade show in the industry and we were both very excited. Due to traveling with almost 30 rare and unique handguns, we decided flying wasn't an option so we rented a car and drove down. During this trip we were even able to make a pit stop at Bud's gun shop outside of Knoxville Tennessee. Lou and I both almost purchased Beretta pistols at Bud's - go figure. Before the show started, we also got to make a stop at the Beretta Gallery in Dallas. I got to hold a 110,000-dollar shotgun and a 12,000 dollar Beretta 92. We got a grand tour of the place to say the least. Thursday morning was set up day. The complex in Dallas is massive, we spent at least a good 20 minutes driving around to find our loading dock. The display went up quickly and smoothly. Friday morning we were up early as judging began at 7:30. I nominated



three pieces from our display for the Silver Medallion - my naval contract C96 Mauser, my Chamelot-Bodeo conversion revolver, and my Beretta 1932. None of these pieces would win recognition, but again, at least for me, this was about the journey not the destination. Our mission was to promote gun collecting for the club and I think we accomplished that very well. Our display would see us getting contact information from a big time Hollywood armorer for the movie industry as he wants to pick our brains about some Italian pieces. Friday saw several people asking to buy the binder that had a paragraph about each piece. A notable group that wanted to purchase the binder was two guys that work with the Canadian Mounties up in Canada. They talked about photographing our collection for their reference library. This personally inspired me to work towards my pipe dream of writing a book on Italian pistols.

Back to the show - we met Brad Taylor, who helped write JB Wood's book on Beretta pistols. In talking with Brad, he could see the passion that we had for Italian military pistols. Through Brad we were able to meet Carlo Beretta (son in the Beretta family and next in line to take over the company) on Saturday. Carlo spent the better part of an hour with us Saturday morning as we brought out all of the pieces on display for him to look over. Carlo took several photos with us and signed some of our books. It was a great experience, and he was extremely kind and



listened patiently to what we had to say. Carlo personally stated how excited he was to see people with such passion for their work. We got introduced to several more big time Beretta employees throughout the weekend and they even talked about bringing us out to a trade show or two in two years to show off our collection for them on the 500th anniversary of their company.

The NRA show had many great vendor booths. We were next to Sig Sauer's massive display (*at left*) where Lou and I both got to handle the US Army's newest weapons. I stopped by PTR to see their

PTR M41 model, a personal favorite of mine. I also held a new PSA Krink in 5.56. I managed to keep myself from ordering a Manurhin MR73 from Beretta (I really want one!). As some people know, most of the guns I buy can't be found in a catalog, so naturally I stopped by Navy Arms and got some info on their latest imports. I also helped James River Armory make three sales on their BM-59's over the weekend!

The Maryland arms collector's association took first place with their display on US Military Presentation Arms. It was an incredible display well deserving of the award.

All and all, for me at least, this NRA Annual Membership meeting was far more about the journey. It was made much more fun by spending time (and having great food) with friends and VGCA members, talking about guns and collecting. Lou and I would like to end this by personally thanking the VGCA for sponsoring us to Dallas. We had a great time. Meet Your Newest Director

Firearms have always been a part of my life - in high school I got a job at a gun range and took 4th place at state in Trap my first year shooting competitively. On the day I turned 21 I proudly submitted the paperwork for my C&R license, which I have maintained since then. Among club members I am known as the Italian military firearms expert. Despite this

It must be the URL shown above. **Do not** go to the regular Lands' End website. It will not show our logo options.


- 2. Above the photo on the home page click on "Men" or "Women"

Source Words Matter: Arms and Democracy By Al Reid, VGCA Legislative Affairs

The 2nd Amendment to The US Constitution was ratified on Dec 15, 1791.

It is logical that the Founding Fathers used the English meaning for "Arms" based on the available dictionaries of the time.

"Noah Webster (1758 – 1843), was a lexicographer and a language reformer, in 1806, Noah Webster published his first dictionary, *A Compendious Dictionary of the English Language*. Then in 1807 he began working on an even more comprehensive edition, and in 1828 this was published as *An American Dictionary of the English Language*." He lived through the time of the Revolution and the ratification of the Constitution. Here's how his authoritative dictionary defined that key word:

'ARMS, noun plural [Latin arma.]

1. Weapons of offense, or armor for defense and protection of the body.

2. War; hostility. Arms and the man I sing. To be in arms to be in a state of hostility, or in a military life. To arms is a phrase which denotes a taking arms for war or hostility; particularly, a summoning to war. To take arms is to arm for attack or defense. Bred to arms denotes that a person has been educated to the profession of a soldier.

3. The ensigns armorial of a family; consisting of figures and colors borne in shields, banners, etc., as marks of dignity and distinction, and descending from father to son.

4. In law, arms are anything which a man takes in his hand in anger, to strike or assault another...

Fire arms are such as may be charged with powder, as cannon, muskets, mortars, etc. A stand of arms consists of a musket, bayonet, cartridge-box and belt, with a sword. But for common soldiers a sword is not necessary...

As Continental Congress Delegate Tench Coxe asserted:

"Who are the militia? Are they not ourselves? Is it feared, then, that we shall turn our arms each man gainst his own bosom. Congress have no power to disarm the militia. Their swords, and every other terrible implement of the soldier, are the birthright of an American.... [T]he unlimited power of the sword is not in the hands of either the federal or state governments, but, where I trust in God it will ever remain, in the hands of the people." (Tench Coxe, The Pennsylvania Gazette, Feb. 20, 1788.)

A book titled, 'Jefferson's Manual' which was printed by the authority, and the order, of the US Senate in 1828. The book is basically Robert's Rule of Order of the day and was given to all members of the Senate and the House of Representatives for reference. Here, the 2nd has one comma. One must know that this is the correct version because the U.S. Senate of the day, only 39 years after the ratification of the Bill of Rights, had it printed, and everyone knew at the time that it must be printed correctly."

Note an important synopsis on the index page that, in a rational world, would put an end to the false argument that prompted the need for the *Heller* case and the entire "the Second Amendment was only intended for the Militia" lie):

"Rights of the Citizen declared to be- to keep and bear arms."

The history of the Second Amendment indicates that its purposes were to secure to each individual the right to keep and bear arms so that he could protect his absolute individual rights as well as carry out his obligation to assist in the common defense. It is evident that the framers of the Constitution did not intend to limit the right to keep and bear arms to a formal military body or organized militia, but intended to provide for an "unorganized" armed citizenry prepared to assist in the common defense against a foreign invader or a domestic tyrant. This concept of an unorganized, armed citizenry clearly recognized the right, and moreover the duty, to keep and bear arms in an individual capacity.

The amendment was written for a specific purpose, not for a specific caliber, nor for a specific action of rifle. It was written for the responsibility of the American citizenry to defend the freedom of our country, against both our current enemies and future enemies, both foreign and domestic. The present munitions situation in our world requires an equal standing for these threats. Were we allowed only muskets to defend ourselves against terrorist attacks, as those who would say that that was the intention of the amendment, we would be seriously outgunned!

Democracy:

It is interesting to note that the word "democracy" does not appear in the US Constitution, and yet it is mentioned daily in political and media dialogue, and by both sides of the political spectrum. Yet the USA is a Constitutional Republic. When have you last heard this term being used in any dialogue and if not, why not? There is one reason that elected officials continue to espouse Democracy, POWER. If the word is used commonly by elected officials it will, in time, become the norm and the populace will soon forget what they have given up!

In layman's terms the difference between a democracy and a Constitutional Republic is simple: In a democracy the people vote in their representatives who are then free to make whatever laws they want under the pretense that you voted for me therefore you support anything they do! Many of these laws then infringe upon or reduce the rights of the individual.

In a Constitutional Republic the people vote in their representative who can make laws, however the Constitution basically tells these representatives what they can and can't do especially in regard to the individual's rights.

It is plain that The Founding Fathers had no time for Democracy, believing that in time Democracy would be used to either subjugate or enslave the people.

On exiting the Constitutional Convention, Benjamin Franklin was asked by a passerby whether the new constitution would provide a monarchy or a republic, Franklin replied "a republic – if you can keep it." Food for thought!

VGCA GUNS OF DISTINCTION: JOSEPH HAMERL FLINTLOCK RIFLE

Joseph Hamerl (1678 to 1738), originally from Wolfratshausen in Bavaria, became a master maker in the Vienna gunsmith guild and Imperial "gun loader" in Vienna in 1710. He also made guns for the courts of Bavaria, Lorraine, and the prince of Lichtenstein. Hamerl made this sporting rifle for Franz Joseph I, the 8th Prince of Liechtenstein (1726–1781) who accompanied his uncle Joseph Wenzel, the 7th Prince, in a campaign in Northern Italy, fighting as field commander at the Battle of Piacenza. The battle was a victory for the Holy Roman Empire, of which Lichtenstein was then a part.



This exquisite rifle is 34.7 inches (88cm) long with a 20.5 inches (52cm) long blued, slightly swamped octagonal barrel. The top of the barrel has the maker's name "JOSEPH HAMERL IN WIENN" inlaid with silver. There is wire inlaid scroll on the breech. There is a dovetailed brass front sight and the iron rear sight has a folding leaf. The flintlock has a flat carved lockplate and rocaille shaped hammer with scroll engraving. The lockplate is delicately engraved with hunting scene of two huntsmen, one with a hound and the other fending off a wild boar with a pike.



The short full stock has light rocaille carving and gilt brass furniture. The sliding patch box lid's brass is engraved with hunting scenes depicting a huntsman shooting a stag. The butt stock has a squared cheekpiece and the wooden triggerguard with finial is strengthened with brass. It has a single set trigger and the wooden ramrod has brass tip.



Close up of the lockplate. Note the engraved scenes of the huntsmen.



There is a manor house (said to be Lichtenstein Castle) engraved on the counter lockplate.



On the wrist is a brass escutcheon engraved with the coat of arms of the Princes of Liechtenstein and a male bust engraved on the buttplate.



Top of the barrel with engraved tang, silver inlaid scrollwork around the breech, and silver inlaid makers name "JOSEPH HAMERL IN WIENN."

This ornately decorated rifle was offered at an auction by Joh. Springer's Erben in Vienna and sold for \$7,138 (6,000 euros). Hamerl made a number of different types of guns for the noble elite, including an air rifle with a butt stock reservoir and pseudo flintlock.

CMP KRAG-JORGENSON RIFLE SALES



The Civilian Marksmanship Program (CMP) announced the release of a limited supply of Krag-Jorgensen rifles. These rifles will be available in 3 variants, distinguished by physical characteristics. The condition of all variants is best described as "Fair", and all have been minimally inspected for completeness and general serviceability. Inventory on these rifles is expected to cap at approximately 800 units across all variants and orders will be processed on a first come-first served basis. The CMP will provide notice via email, social media channels, website and forums when it receives more order requests than it has available rifles.

The three variants are:

- **RKRAGX** These rifles have a 30" barrel. They may have pitting or an uneven finish, often with little or no original finish remaining. The stocks may exhibit cracks, dents and gouges. The rifles may have dark and pitted bores. These rifles have been checked with a field gauge and function fired. The CMP price is \$1,350.
- **RKRAGXCHR** Rifles will be finished in chrome or have a non-traditional finish, indicating that some may have been used as parade rifles. The stocks may be painted, stained or unfinished. The bores may be dark or pitted. Many rifles will have damaged front sights. These rifles have been checked with a field gauge and function fired. The price is \$1,200.
- **RKRAGXSHORT** These rifles have had barrels cut to a shorter length but are NOT carbines. The finish on these rifles will generally be worn and show pitting and may have a chrome or other non-traditional finish. The barrels may be dark and pitted with variations in the muzzle crown and front sight. Some may have '03 style front sights. These rifles have been checked with a field gauge and function fired. These rifles may have a chrome finish. The price is \$1,200.

JUNE SHOW-N-TELL



Member 1 brought in a rare and beautiful rifle, a Swiss Versuchsgewehr 1908 (Test Rifle 1908) (*left*). This rifle was used as a testbed for both the development of the GP-11 7.5x55 Gewehrpatronen as well as serving as a developmental prototype for features adopted in the Schmidt-Rubin IG1911 rifles and also the IG1896/11 rifles converted from the earlier Model 1896 rifles.


Waffenfabrik Bern produced just 900 examples. They served to test different rifling twist rates for the 1911 series of rifles and GP-11 ammunition. This twist rate testing continued into early IG1911 and IG1896/11 rifles.

The 900 test rifles (order approved in January 1909) were made in two different barrel twists – those being 230mm (1 in 9") and 270mm (normal 1 in 10.63"). This rifle shows the barrel stamp indicating the latter barrel twist "7,5 - 270".

Member 1 also shared two books on Swiss cartridges (*below left and right*).



Member 2 (*right*) had a scarce Egyptian Rasheed semi-auto carbine in 7.62x39mm. It is a scaled down version of the Egyptian Hakim rifle. The Hakim Rifle is a gas operated semiautomatic rifle chambered in 8mm Mauser. It was originally designed by Sweden and produced as the Ag m/42 for the Swedish military. The tooling and design were later sold to Egypt. About 8000 Rasheed carbines were produced, roughly equivalent in size and purpose (but not function) to the Russian SKS. Produced at Factory 54 in Egypt from 1966 to 1968, this example was made in in the last year of production. Interestingly this example is stamped "Made in U.A.R." when the United Arab Republic was actually dissolved in 1961. He bought it through this year through a popular on-line firearms auction site.





Member 2 (*above*) also shared a Swiss Schmidt Rubin K-31 straight pull rifle in 7.5x55mm. K-31s were produced from 1931 to 1958 and this one was made by Waffen-Fabrik Bern in 1957. It has the blond beech stock of later production K31s – earlier K31s had a walnut stock. It also features a military 300 meter diopter competition sight (*inset*) and is in excellent condition. It had a soldier tag under the butt plate identifying the Swiss soldier to whom it was issued. It was purchased at the Chantilly gun show two years ago.



Member 3 also brought a James River Armory Beretta Italian BM-59 battle rifle (*at right*). It is semi-automatic and chambered in 7.62/51 NATO. The receiver is marked 2024 and was acquired in 2024.

Member 3 displayed a Mauser C-96 Broomhandle (*left*) that is chambered in 7.63 Mauser. He acquired this semi-automatic pistol in 1987.





The third item Member 3 shared was an M-1 Garand (*at left*). This semiautomatic WWII American classic is chambered in .30/06. This particular example was manufactured by Winchester in September of 1942. Member 3 acquired it in 2013 from via the Civilian Marksmanship Program (CMP).



Member 4 displayed a Swiss Schmidt-Rubin model 1889 rifle (*above*). The Model 1889 was the first in the series of Schmidt–Rubin rifles that served as the primary infantry weapon in Switzerland from 1889 to 1958. The Model 1889 held 12 rounds of <u>GP90 7.5×53.5mm</u>. Production began in 1891 and continued until until 1896. Member 4 purchased this nice example (note the sling and brass muzzle cover) from Edelweiss Arms in 2023.




Member 5 brought in a Swiss Schmidt Rubin K-31 straight pull rifle (*above*) with a Pioneer "sawback" bayonet (*below*). This was not one of the many Swiss K-31s imported to the U.S. about 20 years ago – Member 5 acquired this example in Frankfurt Germany in 1976.



Member 6 presented a Beretta AR-70 semi-automatic rifle (*right*). It is in 5.56x45 caliber and features a long stroke piston action. This was Italy's first 5.56 rifle and the concept was originally developed by a joint venture between SIG and Beretta. Eventually that fell apart, and Beretta moved on to produce the AR-70 and SIG developed the SIG550. The AR-70 uses a proprietary magazine similar to a Stoner magazine and was produced from 1970 to 1990. Member 6 purchased this example this year.






Member 7 (J. Craig Peters) shared another Swiss Schmidt Rubin K-31 straight pull short rifle in 7.5x55mm. This was the final version of the Schmidt Rubin and was produced from 1931-1958. His weapon has a matching bolt, receiver and magazine and was acquired in 2001.



Member 8 brought in both a Ruger Mark I (*left*) and a Mark II (*right*) pistol in .22 caliber. Ruger has produced its .22 pistols from 1947 to the present and has made over million. The Mark II pistol is a standard one but the Mark I is unmarked and has no slide release. The consensus was this is an early Mark I. It was acquired at our VGCA show in 2023.



Member 9 (*right*) showed a Glock 48 in 9mm equipped with an aftermarket Shield Arms 15 round magazine and Trijicon night sights. He purchased it through Capital Supply Co. in June of this year.
